This island is a very special one: it lies in one of the most beautiful parts of the Bahamas and boasts white sandy beaches and the potential for an airstrip. It has all the basic essentials for development. It is situated very near well-known island resorts and existing airstrips. This island is surrounded by crystal clear turquoise waters and features several white sandy beaches -in all approx. 21,650 ft. of water frontage. The highest elevation is approx. 80 ft. which is exceptionally high for the Bahamas. The island can support a 3,000 ft. to 5,000 ft. runway and is adjacent to a deep protected natural harbour. An imposing 7,000-square-foot castle built by an Englishman, Sir Baxter, in 1938 is located on the island. The castle could be rebuilt into a spectacular home or clubhouse. A survey of a proposed development plan is available. A network of paths and walkways extends in southerly and westerly directions for a distance of 1.8 miles.
